Thermal transfer ribbons are used to print text, bar codes, and graphics on a variety of substrates, e.g., paper and labels. The polyester coated film is typically heated from the reverse side by a thermal print head and the pigmented wax/resin coating on the front melts and is transferred to the substrate on which the desired image is formed.

Ingredients: A non-hazardous mixture of inorganic pigment, waxes, and resins coated on thin polyester film. (A very thin layer of silicone oil is applied to the reverse/uncoated side of the polyester to keep the ribbon from burning through during the printing process).
