

**NCR Operating Units
Migrated to ERP / iSP
Updated: May 9, 2016**

To date NCR has migrated the following operating units to the Oracle Enterprise Resource Planning (ERP) platform and enabled the use of iSupplier Portal (iSP).

Many suppliers are required to have an approved NCR Purchase Order (PO) and submit invoices electronically via iSP. ERP POs are 10-digits and can be recognized by a standard 3-digit prefix that corresponds to the operating unit. POs that do not conform to this numbering scheme were generated outside the ERP platform and therefore are not available for electronic invoicing via iSP.

Due to local statutory requirements, electronic invoicing via iSP is not allowed in some countries. Suppliers invoicing NCR POs for these NCR operating units must submit original paper invoices rather than via iSP. However, these suppliers may utilize iSP for its many other self-service features (e.g., view POs, Invoices, and Payments).
